The undersigned is directed to refer to the subject cited above and to state that Ministry of Skill Development & Entrepreneurship (MSDE) has collaborated with The Ministry of Economic Cooperation and Development (BMZ) for the Bund-Länder-Programme (BLP), which is being implemented by GiZ. The BLP program consists of capacity building program for Training of Trainers (ToT) for 36 participants, who will be trained in three batches of twelve members each.

2. The three batches comprise of two technical batches (Batch 1 and Batch 2) and one non-technical women only batch (Batch 3). The training durations for the aforementioned ToT batches are appended in Annexure A.


3. In order to attend the onsite training, candidates will be travelling to Germany in three batches of twelve each, as per the schedule mentioned in Annexure A.
