Detailed report of the activity: Webinar on Budget-2022 for a progressive India was conducted to discuss the budget. A budget analysis is a strategy for evaluating a business's financial well-being. By scrutinizing the budget, you can monitor how much money the business is bringing in and compare that amount to how much money it is spending in a period of time.

Budget analysis is exactly what it sounds like – sitting down with a budget and reviewing it in detail. The purpose of budget analysis is to understand how an organization's money is

being spent and managed, and whether the budget meets the group's goals. The organization could be a business, a government, a charity or any other entity that draws up budgets.

Budget analysis helps companies, governments and non-profit groups organize their finances. Analysts evaluate budget proposals, see if money is being spent productively, and recommend increases or decreases in funding based on their findings. Analysts don't usually have the last word on the budget. Their role is to provide information to the executives or elected officials who do make the call.
