



We have received a complaint of ragging from a student of CENTURION UNIVERSITY OF TECHNOLOGY AND MANAGEMENT. The details are given below.

You are requested to identify & counsel the victim so that he feels safe and knows that authorities are with him & action will be taken on his complaint. You are also requested not to disclose the identity of the victim.

"7.1 Action to be taken by the Head of the institution by the order of Hon. Supreme Court:

on receipt of any information concerningany reported incident of ragging, the Head of institution shall immediately determine if a case under the penal laws is made out and if so, proceed to file a First Information Report (FIR), within twenty four hours of receipt of such information or recommendation, with the police and local authorities, under the appropriate penal provisions relating to one or more of the following, namely; v. Violation of decency and morals through ragging;

MINUTES OF THE MEETING

The Anti-Ragging Committee comprising Internal and External members of the Parlakhemundi Campus of the Centurion University of Technology and Management had the meeting on 14.08.2018 in its Board Room, under the Chairmanship of Dr. S. P. Nanda. Dr. Durga Prasad Padhi, Convener of the Committee welcomed all the members to the meeting and initiated the discussion relating to the complaint filed (vide Case No. ARCC/OR-4573, Dated 11-08-2018 in the MHRD website) by the brother of a student studying in 2nd Year Civil Engineering branch. The details of the discussions, findings and actions are given below.

- 1. The committee members had detail discussion with the complainant, complainant's brother (2nd year student) and the accused students.
- 2. There was discussion among the complainant's brother (second year student) and four other students (Mr. Seraj Chowdary, 3rd year Diploma Mechanical, Mr. Anish Kumar Singh, 4th year B. Tech. Mechanical, Mr. Amit Kumar, 3rd year Diploma Mechanical, Mr. Shubham Kumar, 4th year B. Tech CSE and Mr. Prakash Mishra, 3rd year Diploma Mechanical) outside the Auditorium on 3rd August after an informal interaction. All the students involved in the discussion belong to same locality, i.e. Jamshedpur. The discussion led to argument on different topics. They had verbal altercation on trivial issues (referring somebody as "TUM" instead of "AAP"). The second year student felt offended that his views were not respected by others and making a trivial issue as serious. Out of disgust he informed his brother about his unhappiness. Subsequently his brother, who lives in Kolkata, filed a complaint at the HRD website without enquiring the real situation.
 - 3. The Committee found that it was a case of misunderstanding and misreporting.

- 7. The Complainant has requested not to dwell further on this small issue.
- 8. Students involved in this issue have been warned and undertaking is taken from the students not to involve in such activities in future or else disciplinary action may be initiated.
- 9. The meeting was adjourned with a vote of thanks to the Chair.
