MEMORANDUM OF AGREEMENT

This MEMORANDUM OF AGREEMENT is made on this 25th day of January two thousand and nineteen BY AND BETWEEN, Rama Devi Women's University, a state University established under the Odisha University Act – 1989, having its registered office at Bhoi Nagar, Unit-9, Bhubaneswar-751022, Odisha, hereinafter referred to as the 'RDWU' (which expression shall where the context so admits include its successors and permitted assigns) of the ONE PART;

AND

Centurion University of Technology and Management, Bhubaneswar, a state private University established under the Centurion University Act no. 4 of state legislature of Odisha, 2010 having its registered office at 17, Forest Park, Bhuabneswar-751009, Odisha hereinafter referred to as 'CUTM' (which expression shall where the context so admits include its successors and permitted assigns) of the OTHER PART;

WHEREAS RDWU being desirous of imparting skill based research training to its students decided to collaborate with CUTM on a project with similar objectives sanctioned by Government of Odisha for the attainment of the objectives, hereinafter described in the project proposal approved by Govt. of Odisha annexed hereto;

This Memorandum of Agreement (MoA) defines the role and responsibilities of the collaborating agencies, monitoring and other matters related to the "Skill development training of RDWU students".

NOW THE PARTIES HERETO AGREE AS FOLLOWS:-

1.0. ROLE OF RDWU, BHUBANESWAR

- 1.1. To provide funds to the extent of Rs. 89,95,054/- (Rupees eighty nine lakhs ninety five thousand fifty four only) within 31st March 2020 from the date of signing of this agreement, to CUTM for undertaking activities as detailed in the Govt. of Odisha approved project. Details of the funds to be provided are given in Annexure- I.
- 1.2. To list students from Arts, Science and Commerce streams of RDWU who would be taking up the skill development and training under the seven different categories as per the approved project.

2.0. ROLE OF CUTM, BHUBANESWAR

- 2.1. Setting up skill Centre and Laboratory/training facilities for selected courses within the campus of the RDWU.
- 2.2. To finalize the delivery model and preparation of the training calendar.
- 2.3. To customize and design modules for seven different courses and mentioned in the Govt. of Odisha approved project to be offered at RDWU.
- 2.4. To conduct the identified seven skill based training programme for 420 RDWU students for a duration of 120 hours within the duration of the project in sync with the academic year of RDWU.
- 2.5. To be responsible for accomplishing objectives identified and activities listed in the Govt. of Odisha approved project as annexed herewith.
- To provide resource personnel for imparting campus based skill development training to RDWU students
- 2.7. To manage training expanses, consulting and training support expanses, food expanses, student field visit and associated cost and certification cost for skill development and training of RDWU students.
- To prepare and submit all periodical reports and other documents that would be required by RDWU.
- To maintain a separate audit head of account for the grants received from RDWU for the project.
- 2.10. To submit interim and an annual audited statement of expenditure incurred under the project.
- 2.11. To ensure effective utilization of the grant released by RDWU for the purpose for which it was granted and to ensure timely progress of the project.

3.0 DURATION OF PROJECT

3.1 Duration of the project shall be until 31st March 2020 from the date of the release of first instalment of funds by RDWU to CUTM.

4.0 TERMS & CONDITIONS FOR RELEASE OF FUNDS TO CUTM

- 4.1 RDWU will release a sum of Rs. 43,11,254/- (Rupees forty three lakhs eleven thousand two hundred fifty four only) under the head for Laboratory development of RDWU (including Rs. 20,00,362/- under the subhead 2.1 for infrastructure development and procurement of laboratory materials and Rs. 23,10,892/- under the subhead 2.2 towards procurement of consumables and miscellaneous items for skill training) as first instalment of fund to CUTM upon signing of the agreement. CUTM will provide a blueprint-cum-sketch plan of skill laboratories to be developed by them within the RDWU campus before the release of first instalment of funds.
- 4.2 The civil as well as other associated work for infrastructure development, procurement of laboratory materials, consumable and other miscellaneous items for skill training within the RDWU campus shall be executed by CUTM and should be completed within 50 (Fifty) days of the release of funds.
- A sum of Rs. 13,93,267/- (Rupees thirteen Lakhs ninety three thousand two hundred sixty seven only) (including Rs. 705600/- under the head of training expenses, Rs. 1,30,667/- under the head of consulting and training support fee, Rs. 1,82,000/- under the head of student field visit and transportation cost and Rs. 375000/- under the head of Food expenses) will be released as second instalment of funds to CUTM before the start of skill training programme in the RDWU campus and after facilitation of interim UC-SE for the first instalment of funds to RDWU.
- A sum of Rs. 13,93,267/- (Rupees thirteen Lakhs ninety three thousand two hundred sixty seven only) (including Rs. 7,05,600/- under the head of training expenses, Rs. 1,30,667/- under the head of consulting and training support fee, Rs. 1,82,000/- under the head of student field visit and transportation cost and Rs. 3,75,000/- under the head of Food expenses) will be released as third instalment of funds to CUTM after the completion of 40 hours and before the start of second phase of training (41 to 80 hrs) of skill training programme in the RDWU campus subject to facilitation of interim UC-SE for the second instalment of funds to RDWU.
- A sum of Rs. 13,93,266/- (Rupees thirteen Lakhs ninety three thousand two hundred sixty six only) (including Rs. 7,05,600/- under the head of training expenses, Rs. 1,30,666/- under the head of consulting and training support fee, Rs. 1,82,000/- under the head of student field visit and transportation cost and Rs. 3,75,000/- under the head of Food expenses) will be released as fourth instalment of funds to CUTM after the completion of 80 pours and before the

start of third phase of training (81 to 120 hrs) of skill training programme in the RDWU campus subject to facilitation of interim UC-SE for the third instalment of funds to RDWU.

- 4.6 The final instalment of Rs. 5, 04,000/- under the head of certification cost will be released to CUTM after the submission of final audited UC-SE to RDWU.
- 4.7 The know-how generated from the project by CUTM will be the joint property of RDWU and CUTM. It shall be the responsibility of CUTM to take necessary action for protection of the intellectual property arising out of the PROJECT through proper instruments, such as, patents, copy rights, etc.
- 4.8 All the assets including the equipment and produce acquired will be the property of RDWU and shall not be utilized for purposes other than those for which the grant has been released. The rights of CUTM under this MOA shall not be transferred to any other party without prior approval in writing of RDWU.

5. SECRECY

It is hereby agreed that the participating agencies shall keep information and data collected completely secret provided that the right to transfer the technology shall rest with the RDWU.

6. MONITORING

- 6.1 The progress of implementation of the project and proper utilization of grant shall be reviewed by RDWU and by the Skill development Committee set up by RDWU.
- 6.2 The periodic progress of physical achievements and the utilization of funds, statement of expenditure shall be evaluated by the Skill development Committee.
- 6.3 The Comptroller of Finance, RDWU at his discretion shall have the right of access to the books and accounts of CUTM for the grants received from RDWU for this project.
- 6.4 RDWU may hold the grant at any stage if it is convinced that the grant has not been properly utilized or appropriate progress has not been made. In the event, RDWU terminates the grant, CUTM shall hand over all documents including technical details and equipment purchased related to the project.

7.0 DURATION OF MEMORANDUM OF AGREEMENT

This MoA will remain inforce for the duration of the project and until all claims are settled between RDWU and CUTM.

8.0 ARBITRATION

8.1. As a general principle, the designated RDWU and CUTM shall work in a cohesive and cooperative environment.

In the event of any question, dispute or difference whatsoever arising between 8.2. the parties to this Agreement out of or relating to the construction, meaning, scope, operation or effect of this Agreement or the validity of the breach thereof shall be referred to an Arbitrator to be appointed by mutual consent of both the parties herein. If the parties cannot agree on the appointment of the Arbitrator within a period of one month from the notification by one party to the other of existence of such dispute, then the same will be resolved in accordance with the norms and procedures laid down by Govt. of Odisha in this regard.

9.0. **GOVERNING LAW**

This Contract shall be governed by the Law of India for the time being in force.

TERMS & CONDITIONS OF THE GRANT

(To be signed and enclosed with MoA)

- 1. Approval for the grant released would be for the specific project mentioned and grant should be exclusively spent on the project for which it has been sanctioned within the stipulated time. CUTM is not permitted to seek or utilize funds from any other organization (Government, Semi Government, Autonomous or Private) for this project. Any unspent part of amount would be surrendered to RDWU through an account payee demand draft drawn in favour of the "Comptroller of Finance, Rama Devi Women's University, Bhubaneswar".
- For permanent/semi-permanent assets acquired solely or mainly out of the grant, 2. an audited record in the form of a register shall be maintained by CUTM and shall be handed over to RDWU after the completion of the project.
- 3. All the assets acquired from the grant will be the property of RDWU and should not without the prior sanction of the RDWU, be disposed of, or encumbered or utilised for purpose other than those for which the grant has been sanctioned.
- At the conclusion of the project, RDWU will be free to sell or otherwise dispose 4. of assets or retain the assets created under the project for carrying out similar work for the promotion of skill development and training in RDWU.
- 5. CUTM will furnish progress report of work on the project every six months. The progress of the project will be reviewed/monitored by the Skill development Committee of RDWU. In addition, RDWU shall designate Scientists/Specialists to visit the training facility periodically for reviewing the progress of work and for suggesting such measures as to ensure early realisation of the objectives of the project. On completion of the project five copies of a consolidated report of the work done on the subject would be submitted to RDWU.
- CUTM would furnish to RDWU a Utilization Certificate and an audited 6. statement of expenditure duly signed by the Head of the Institute and the Head of the Finance wing, pertaining to the grant before the release of subsequent installments as well as a consolidated statement of expenditure at the end of the completion of the project.
- 7. A stamped receipt be sent to RDWU on receipt of the Cheque/ Demand draft towards each release.
- The Comptroller of Finance, RDWU at his discretion shall have the right of 8. access to the books and accounts of the CUTM for the grant received from RDWU.

- CUTM would maintain separate audited accounts for the project. If it is found expedient to keep a part or whole of the grant in a bank account earning interest, the interest thus earned should be reported to RDWU.
- 10. CUTM may not entrust the implementation of the work for which the grant is being sanctioned to another institution and to divert the grant receipts as assistance to the latter institution. However, in such situations the express permission of RDWU may be obtained. In case the grantee is not in a position to execute or complete the project, it may be required to refund forthwith to the RDWU the entire amount of grant received by it.
- 11. The human resources that may be engaged for the project by CUTM are not to be treated as employees of RDWU and the deployment of such human resource at the time of completion or termination of project, will not be the concern/responsibility of RDWU.
- 12. RDWU reserves the right to terminate the grant at any stage and also to recover the amounts already paid if it is convinced that the grant has not been properly utilized or the work on the project has been suspended for any unduly long period or appropriate progress is not being made.
- 13. The project will become operative with effect from the date of release of the first instalment for the project.



CL and CUTM shall be hereinafter individually be referred as "Party" and collectively 'Parties".

EREAS "HPCL" is a Government Company in the business of refining and marketing bleum products throughout the country, through its dealer network.

WHEREAS CUTM is an educational institute imparting quality and accredited academic rammes in technology and management.

WHEREAS CUTM has requested HPCL for financial support for providing Technical to 200 differently abled youth (hereinafter referred as Project) in CUTM Campus in Jatni, a (hereinafter referred as Project).

WHEREAS HPCL based on the above request by CUTM has agreed to provide a financial rt of not exceeding Rs. 1,80,00,000/- (Rupees One Crore and Eighty Lakhs Only) towards nenting the Project.





NOW THEREFORE, IN CONSIDERATION OF THE FOREGOING, THE PARTIES HEREIN MUTUALLY AGREE TO THE TERMS AND CONDITIONS HEREIN SETFORTH;

OBJECTIVE

It is hereby agreed by both the Parties that the main objective of this MOU is to provide Long-term skilling of 200 differently abled youth in CUTM Campus in Jatni, Odisha.

IMPLEMENTATION PLAN:

- That it is agreed that HPCL shall provide financial support to CUTM for the Project of developing technical skill and capacity building providing long-term Technical skills to 200 nos. of differently abled youths.
- b) That CUTM agrees to conduct courses to impart technical skills and capacity building to differently abled youth strictly in accordance with details mentioned below:

- d) That CUTM shall ensure placement of the 200 differently abled youths trained under the project.
- e) That all the 200 nos. beneficiaries of the project shall necessarily be Persons with Disability holding certificate in this regard from a competent authority.
- f) That the 200 nos. beneficiaries shall be from economically weaker sections of society having a family income of less than Rs. 10,000/- per month.
- g) That the project will be implemented by the CUTM in an efficient manner and the funds so provided shall be judiciously used for this purpose only.
- h) That it is agreed that, during the period of project implementation, HPCL representatives shall have access to review the progress and monitor the quality of training, boarding and lodging provided by CUTM.
- i) Selection of beneficiaries
 - i. It shall be sole responsibility of CUTM to select candidates on two principles of "equal opportunity" and "transparency".
 - ii. All the Candidates / Beneficiaries should be of Indian Nationality, in the age group of 18 to 40 years.
 - iii. Sourcing of candidates would be done through one or a combination of the methods including but not limited to Advertising in local media, Posters, Word of mouth, Institutional communication, assistance from local school principals to identify school drop outs, etc. Records of these activities for all beneficiaries shall be made available to HPCL.
 - iv. CUTM shall not charge any fees from the Candidate for training, food and accommodation during the entire period of the training.
- j) That it is agreed that, the work on the project shall commence within one month of signing of this MOU.
- k) That the Project shall be implemented at GTET Skill Training Centre, Jatni, Khurda, Orissa.
- 1) That CUTM shall prepare a detailed project implementation plan and share with HPCL within 15 days of signing of this MOU.
- m) That CUTM shall submit names, address and other details of all beneficiaries to HPCL in format suggested by HPCL along with the details of Disability Certificate issued by competent authority.
- n) That CUTM shall submit a quarterly monthly project progress report showing the details of the training, providing name, address of trainees to HPCL in the format suggested by HPCL.
- o) It is hereby agreed that CUTM shall endevaour to complete the project within one year form the date of signing of this MOU. Any extension in the period of completion will require written consent of HPCL.
- p) It is hereby agreed that the financial contribution of HPCL to the project shall be limited to supporting training cost and reimbursement towards food and accommodation of 200 candidates at a cost of Rs 90,000 per candidate up to a financial limit of Rs. 1,80,00,000/-(Rupees One Crore, Eighty Lakhs, only).

- q) That it is agreed that, the work shall be executed as per the time schedule and for any delay, HPCL shall not be responsible. - c) CUTM agrees not to abandon /discontinue the project implementation in between/ before its completion.
- d) CUTM agrees to complete the training within 4 quarters from the date of finalization of beneficiaries. But in no case same is to be delayed beyond 31-01-2020.
- e) In case CUTM obtain financial support from any other entity for the same activity which is being supported by HPCL a detailed account of receipt and application of funds for the particular activity to be submitted to HPCL.

Notwithstanding anything contained herein, under no circumstance, HPCL shall pay more than Rs. 90,000/- per beneficiary.

It is hereby agreed and acknowledged that the overall HPCL's liability towards the project shall be limited to Rs. 1,80,00,000/- (Rupees One Crore and Eighty Lakhs Only) inclusive of all taxes or actual expenditure, whichever is lowest.

In case, any amount received by CUTM is unutilized after completion of the project, CUTM hereby agrees that the same shall be returned by CUTM to HPCL within 30 days of receipt of communication from HPCL in this regard.

IV. FORCE MAJEURE

- a) Either party shall be excused from performance of this MOU during and to the extent that performance is prevented by the occurrence of unforeseen causes beyond the reasonable control of the Party by and without the negligence of the party claiming excuse.
- b) Such causes include, without limitation, acts of god, war, fire, explosion, earthquake, flood, and government restrictions. The party claiming excuse shall give immediate written notice thereof to the other, in any case not later than 15 days, following the occurrence of such event.
- c) If performance is held up for a continuous period of more than 4 months from the date of first notice, then the two parties shall review the situation and agree upon a course of action so as to protect their interest. Centurion University of Technology and Management, Bhubaneswar, a state private University established under the Centurion University Act no. 4 of state legislature of Odisha, 2010 having its registered office at 17, Forest Park, Bhuabneswar-751009, Odisha hereinafter referred to as 'CUTM' (which expression shall where the context so admits include its successors and permitted assigns) of the OTHER PART;

WHEREAS RDWU being desirous of imparting skill based research training to its students decided to collaborate with CUTM on a project with similar objectives sanctioned by Government of Odisha for the attainment of the objectives, hereinafter described in the project proposal approved by Govt. of Odisha annexed hereto;

This Memorandum of Agreement (MoA) defines the role and responsibilities of the collaborating agencies, monitoring and other matters related to the "Skill development training of RDWU students".

NOW THE PARTIES HERETO AGREE AS FOLLOWS:-

1.0. ROLE OF RDWU, BHUBANESWAR

- 1.1. To provide funds to the extent of Rs. 89,95,054/- (Rupees eighty nine lakhs ninety five thousand fifty four only) within 31st March 2020 from the date of signing of this agreement, to CUTM for undertaking activities as detailed in the Govt. of Odisha approved project. Details of the funds to be provided are given in Annexure- I.
- 1.2. To list students from Arts, Science and Commerce streams of RDWU who would be taking up the skill development and training under the seven different categories as per the approved project.

2.0. ROLE OF CUTM, BHUBANESWAR

- 2.1. Setting up skill Centre and Laboratory/training facilities for selected courses within the campus of the RDWU.
- 2.2. To finalize the delivery model and preparation of the training calendar.
- 2.3. To customize and design modules for seven different courses and mentioned in the Govt. of Odisha approved project to be offered at RDWU.
- 2.4. To conduct the identified seven skill based training programme for 420 RDWU students for a duration of 120 hours within the duration of the project in sync with the academic year of RDWU.
- 2.5. To be responsible for accomplishing objectives identified and activities listed in the Govt. of Odisha approved project as annexed herewith.
- To provide resource personnel for imparting campus based skill development training to RDWU students
- 2.7. To manage training expanses, consulting and training support expanses, food expanses, student field visit and associated cost and certification cost for skill development and training of RDWU students.
- To prepare and submit all periodical reports and other documents that would be required by RDWU.
- To maintain a separate audit head of account for the grants received from RDWU for the project.
- 2.10. To submit interim and an annual audited statement of expenditure incurred under the project.
- 2.11. To ensure effective utilization of the grant released by RDWU for the purpose for which it was granted and to ensure timely progress of the project.

3.0 DURATION OF PROJECT

3.1 Duration of the project shall be until 31st March 2020 from the date of the release of first instalment of funds by RDWU to CUTM.

4.0 TERMS & CONDITIONS FOR RELEASE OF FUNDS TO CUTM

- 4.1 RDWU will release a sum of Rs. 43,11,254/- (Rupees forty three lakhs eleven thousand two hundred fifty four only) under the head for Laboratory development of RDWU (including Rs. 20,00,362/- under the subhead 2.1 for infrastructure development and procurement of laboratory materials and Rs. 23,10,892/- under the subhead 2.2 towards procurement of consumables and miscellaneous items for skill training) as first instalment of fund to CUTM upon signing of the agreement. CUTM will provide a blueprint-cum-sketch plan of skill laboratories to be developed by them within the RDWU campus before the release of first instalment of funds.
- 4.2 The civil as well as other associated work for infrastructure development, procurement of laboratory materials, consumable and other miscellaneous items for skill training within the RDWU campus shall be executed by CUTM and should be completed within 50 (Fifty) days of the release of funds.
- 4.3 A sum of Rs. 13,93,267/- (Rupees thirteen Lakhs ninety three thousand two hundred sixty seven only) (including Rs. 705600/- under the head of training expenses, Rs. 1,30,667/- under the head of consulting and training support fee, Rs. 1,82,000/- under the head of student field visit and transportation cost and Rs. 375000/- under the head of Food expenses) will be released as second instalment of funds to CUTM before the start of skill training programme in the RDWU campus and after facilitation of interim UC-SE for the first instalment of funds to RDWU.
- A sum of Rs. 13,93,267/- (Rupees thirteen Lakhs ninety three thousand two hundred sixty seven only) (including Rs. 7,05,600/- under the head of training expenses, Rs. 1,30,667/- under the head of consulting and training support fee, Rs. 1,82,000/- under the head of student field visit and transportation cost and Rs. 3,75,000/- under the head of Food expenses) will be released as third instalment of funds to CUTM after the completion of 40 hours and before the start of second phase of training (41 to 80 hrs) of skill training programme in the RDWU campus subject to facilitation of interim UC-SE for the second instalment of funds to RDWU.
- 4.5 A sum of Rs. 13,93,266/- (Rupees thirteen Lakhs ninety three thousand two hundred sixty six only) (including Rs. 7,05,600/- under the head of training expenses, Rs. 1,30,666/- under the head of consulting and training support fee, Rs. 1,82,000/- under the head of student field visit and transportation cost and Rs. 3,75,000/- under the head of Food expenses) will be released as fourth instalment of funds to CUTM after the completion of 80 mours and before the

start of third phase of training (81 to 120 hrs) of skill training programme in the RDWU campus subject to facilitation of interim UC-SE for the third instalment of funds to RDWU.

- 4.6 The final instalment of Rs. 5, 04,000/- under the head of certification cost will be released to CUTM after the submission of final audited UC-SE to RDWU.
- 4.7 The know-how generated from the project by CUTM will be the joint property of RDWU and CUTM. It shall be the responsibility of CUTM to take necessary action for protection of the intellectual property arising out of the PROJECT through proper instruments, such as, patents, copy rights, etc.
- 4.8 All the assets including the equipment and produce acquired will be the property of RDWU and shall not be utilized for purposes other than those for which the grant has been released. The rights of CUTM under this MOA shall not be transferred to any other party without prior approval in writing of RDWU.

5. SECRECY

It is hereby agreed that the participating agencies shall keep information and data collected completely secret provided that the right to transfer the technology shall rest with the RDWU.

6. MONITORING

- 6.1 The progress of implementation of the project and proper utilization of grant shall be reviewed by RDWU and by the Skill development Committee set up by RDWU.
- 6.2 The periodic progress of physical achievements and the utilization of funds, statement of expenditure shall be evaluated by the Skill development Committee.
- 6.3 The Comptroller of Finance, RDWU at his discretion shall have the right of access to the books and accounts of CUTM for the grants received from RDWU for this project.
- 6.4 RDWU may hold the grant at any stage if it is convinced that the grant has not been properly utilized or appropriate progress has not been made. In the event, RDWU terminates the grant, CUTM shall hand over all documents including technical details and equipment purchased related to the project.

7.0 DURATION OF MEMORANDUM OF AGREEMENT

This MoA will remain inforce for the duration of the project and until all claims are settled between RDWU and CUTM.

8.0 ARBITRATION

8.1. As a general principle, the designated RDWU and CUTM shall work in a cohesive and cooperative environment.

TERMS & CONDITIONS OF THE GRANT

(To be signed and enclosed with MoA)

- 1. Approval for the grant released would be for the specific project mentioned and grant should be exclusively spent on the project for which it has been sanctioned within the stipulated time. CUTM is not permitted to seek or utilize funds from any other organization (Government, Semi Government, Autonomous or Private) for this project. Any unspent part of amount would be surrendered to RDWU through an account payee demand draft drawn in favour of the "Comptroller of Finance, Rama Devi Women's University, Bhubaneswar".
- For permanent/semi-permanent assets acquired solely or mainly out of the grant, 2. an audited record in the form of a register shall be maintained by CUTM and shall be handed over to RDWU after the completion of the project.
- 3. All the assets acquired from the grant will be the property of RDWU and should not without the prior sanction of the RDWU, be disposed of, or encumbered or utilised for purpose other than those for which the grant has been sanctioned.
- At the conclusion of the project, RDWU will be free to sell or otherwise dispose 4. of assets or retain the assets created under the project for carrying out similar work for the promotion of skill development and training in RDWU.
- 5. CUTM will furnish progress report of work on the project every six months. The progress of the project will be reviewed/monitored by the Skill development Committee of RDWU. In addition, RDWU shall designate Scientists/Specialists to visit the training facility periodically for reviewing the progress of work and for suggesting such measures as to ensure early realisation of the objectives of the project. On completion of the project five copies of a consolidated report of the work done on the subject would be submitted to RDWU.
- CUTM would furnish to RDWU a Utilization Certificate and an audited 6. statement of expenditure duly signed by the Head of the Institute and the Head of the Finance wing, pertaining to the grant before the release of subsequent installments as well as a consolidated statement of expenditure at the end of the completion of the project.
- 7. A stamped receipt be sent to RDWU on receipt of the Cheque/ Demand draft towards each release.
- The Comptroller of Finance, RDWU at his discretion shall have the right of 8. access to the books and accounts of the CUTM for the grant received from RDWU.

- CUTM would maintain separate audited accounts for the project. If it is found expedient to keep a part or whole of the grant in a bank account earning interest, the interest thus earned should be reported to RDWU.

However, in such situations the express permission of RDWU may be obtained. In case the grantee is not in a position to execute or complete the project, it may be required to refund forthwith to the RDWU the entire amount of grant received by it.
- 11. The human resources that may be engaged for the project by CUTM are not to be treated as employees of RDWU and the deployment of such human resource at the time of completion or termination of project, will not be the concern/responsibility of RDWU.
- 12. RDWU reserves the right to terminate the grant at any stage and also to recover the amounts already paid if it is convinced that the grant has not been properly utilized or the work on the project has been suspended for any unduly long period or appropriate progress is not being made.
- 13. The project will become operative with effect from the date of release of the first instalment for the project.





MEMORANDUM OF AGREEMENT

This MEMORANDUM OF AGREEMENT is made on this 25th day of January two thousand and nineteen BY AND BETWEEN, Rama Devi Women's University, a state University established under the Odisha University Act – 1989, having its registered office at Bhoi Nagar, Unit-9, Bhubaneswar-751022, Odisha, hereinafter referred to as the 'RDWU' (which expression shall where the context so admits include its successors and permitted assigns) of the ONE PART;

AND

Centurion University of Technology and Management, Bhubaneswar, a state private University established under the Centurion University Act no. 4 of state legislature of Odisha, 2010 having its registered office at 17, Forest Park, Bhuabneswar-751009, Odisha hereinafter referred to as 'CUTM' (which expression shall where the context so admits include its successors and permitted assigns) of the OTHER PART;

WHEREAS RDWU being desirous of imparting skill based research training to its students decided to collaborate with CUTM on a project with similar objectives sanctioned by Government of Odisha for the attainment of the objectives, hereinafter described in the project proposal approved by Govt. of Odisha annexed hereto;

This Memorandum of Agreement (MoA) defines the role and responsibilities of the collaborating agencies, monitoring and other matters related to the "Skill development training of RDWU students".

NOW THE PARTIES HERETO AGREE AS FOLLOWS:-

1.0. ROLE OF RDWU, BHUBANESWAR

- 1.1. To provide funds to the extent of Rs. 89,95,054/- (Rupees eighty nine lakhs ninety five thousand fifty four only) within 31st March 2020 from the date of signing of this agreement, to CUTM for undertaking activities as detailed in the Govt. of Odisha approved project. Details of the funds to be provided are given in Annexure- I.
- 1.2. To list students from Arts, Science and Commerce streams of RDWU who would be taking up the skill development and training under the seven different categories as per the approved project.

2.0. ROLE OF CUTM, BHUBANESWAR

- 2.1. Setting up skill Centre and Laboratory/training facilities for selected courses within the campus of the RDWU.
- 2.2. To finalize the delivery model and preparation of the training calendar.
- 2.3. To customize and design modules for seven different courses and mentioned in the Govt. of Odisha approved project to be offered at RDWU.
- 2.4. To conduct the identified seven skill based training programme for 420 RDWU students for a duration of 120 hours within the duration of the project in sync with the academic year of RDWU.
- 2.5. To be responsible for accomplishing objectives identified and activities listed in the Govt. of Odisha approved project as annexed herewith.
- To provide resource personnel for imparting campus based skill development training to RDWU students
- 2.7. To manage training expanses, consulting and training support expanses, food expanses, student field visit and associated cost and certification cost for skill development and training of RDWU students.
- 2.8. To prepare and submit all periodical reports and other documents that would be required by RDWU.
- To maintain a separate audit head of account for the grants received from RDWU for the project.
- 2.10. To submit interim and an annual audited statement of expenditure incurred under the project.
- 2.11. To ensure effective utilization of the grant released by RDWU for the purpose for which it was granted and to ensure timely progress of the project.

3.0 DURATION OF PROJECT

3.1 Duration of the project shall be until 31st March 2020 from the date of the release of first instalment of funds by RDWU to CUTM.

4.0 TERMS & CONDITIONS FOR RELEASE OF FUNDS TO CUTM

- 4.1 RDWU will release a sum of Rs. 43,11,254/- (Rupees forty three lakhs eleven thousand two hundred fifty four only) under the head for Laboratory development of RDWU (including Rs. 20,00,362/- under the subhead 2.1 for infrastructure development and procurement of laboratory materials and Rs. 23,10,892/- under the subhead 2.2 towards procurement of consumables and miscellaneous items for skill training) as first instalment of fund to CUTM upon signing of the agreement. CUTM will provide a blueprint-cum-sketch plan of skill laboratories to be developed by them within the RDWU campus before the release of first instalment of funds.
- 4.2 The civil as well as other associated work for infrastructure development, procurement of laboratory materials, consumable and other miscellaneous items for skill training within the RDWU campus shall be executed by CUTM and should be completed within 50 (Fifty) days of the release of funds.
- 4.3 A sum of Rs. 13,93,267/- (Rupees thirteen Lakhs ninety three thousand two hundred sixty seven only) (including Rs. 705600/- under the head of training expenses, Rs. 1,30,667/- under the head of consulting and training support fee, Rs. 1,82,000/- under the head of student field visit and transportation cost and Rs. 375000/- under the head of Food expenses) will be released as second instalment of funds to CUTM before the start of skill training programme in the RDWU campus and after facilitation of interim UC-SE for the first instalment of funds to RDWU.
- A sum of Rs. 13,93,267/- (Rupees thirteen Lakhs ninety three thousand two hundred sixty seven only) (including Rs. 7,05,600/- under the head of training expenses, Rs. 1,30,667/- under the head of consulting and training support fee, Rs. 1,82,000/- under the head of student field visit and transportation cost and Rs. 3,75,000/- under the head of Food expenses) will be released as third instalment of funds to CUTM after the completion of 40 hours and before the start of second phase of training (41 to 80 hrs) of skill training programme in the RDWU campus subject to facilitation of interim UC-SE for the second instalment of funds to RDWU.
- A sum of Rs. 13,93,266/- (Rupees thirteen Lakhs ninety three thousand two hundred sixty six only) (including Rs. 7,05,600/- under the head of training expenses, Rs. 1,30,666/- under the head of consulting and training support fee, Rs. 1,82,000/- under the head of student field visit and transportation cost and Rs. 3,75,000/- under the head of Food expenses) will be released as fourth instalment of funds to CUTM after the completion of 80 pours and before the

start of third phase of training (81 to 120 hrs) of skill training programme in the RDWU campus subject to facilitation of interim UC-SE for the third instalment of funds to RDWU.

- 4.6 The final instalment of Rs. 5, 04,000/- under the head of certification cost will be released to CUTM after the submission of final audited UC-SE to RDWU.
- 4.7 The know-how generated from the project by CUTM will be the joint property of RDWU and CUTM. It shall be the responsibility of CUTM to take necessary action for protection of the intellectual property arising out of the PROJECT through proper instruments, such as, patents, copy rights, etc.
- 4.8 All the assets including the equipment and produce acquired will be the property of RDWU and shall not be utilized for purposes other than those for which the grant has been released. The rights of CUTM under this MOA shall not be transferred to any other party without prior approval in writing of RDWU.

5. SECRECY

It is hereby agreed that the participating agencies shall keep information and data collected completely secret provided that the right to transfer the technology shall rest with the RDWU.

6. MONITORING

- 6.1 The progress of implementation of the project and proper utilization of grant shall be reviewed by RDWU and by the Skill development Committee set up by RDWU.
- 6.2 The periodic progress of physical achievements and the utilization of funds, statement of expenditure shall be evaluated by the Skill development Committee.
- 6.3 The Comptroller of Finance, RDWU at his discretion shall have the right of access to the books and accounts of CUTM for the grants received from RDWU for this project.
- 6.4 RDWU may hold the grant at any stage if it is convinced that the grant has not been properly utilized or appropriate progress has not been made. In the event, RDWU terminates the grant, CUTM shall hand over all documents including technical details and equipment purchased related to the project.

7.0 DURATION OF MEMORANDUM OF AGREEMENT

This MoA will remain inforce for the duration of the project and until all claims are settled between RDWU and CUTM.

8.0 ARBITRATION

8.1. As a general principle, the designated RDWU and CUTM shall work in a cohesive and cooperative environment.

In the event of any question, dispute or difference whatsoever arising between 8.2. the parties to this Agreement out of or relating to the construction, meaning, scope, operation or effect of this Agreement or the validity of the breach thereof shall be referred to an Arbitrator to be appointed by mutual consent of both the parties herein. If the parties cannot agree on the appointment of the Arbitrator within a period of one month from the notification by one party to the other of existence of such dispute, then the same will be resolved in accordance with the norms and procedures laid down by Govt. of Odisha in this regard.

9.0. **GOVERNING LAW**

This Contract shall be governed by the Law of India for the time being in force.

TERMS & CONDITIONS OF THE GRANT

(To be signed and enclosed with MoA)

- 1. Approval for the grant released would be for the specific project mentioned and grant should be exclusively spent on the project for which it has been sanctioned within the stipulated time. CUTM is not permitted to seek or utilize funds from any other organization (Government, Semi Government, Autonomous or Private) for this project. Any unspent part of amount would be surrendered to RDWU through an account payee demand draft drawn in favour of the "Comptroller of Finance, Rama Devi Women's University, Bhubaneswar".
- For permanent/semi-permanent assets acquired solely or mainly out of the grant, 2. an audited record in the form of a register shall be maintained by CUTM and shall be handed over to RDWU after the completion of the project.
- 3. All the assets acquired from the grant will be the property of RDWU and should not without the prior sanction of the RDWU, be disposed of, or encumbered or utilised for purpose other than those for which the grant has been sanctioned.
- At the conclusion of the project, RDWU will be free to sell or otherwise dispose 4. of assets or retain the assets created under the project for carrying out similar work for the promotion of skill development and training in RDWU.
- 5. CUTM will furnish progress report of work on the project every six months. The progress of the project will be reviewed/monitored by the Skill development Committee of RDWU. In addition, RDWU shall designate Scientists/Specialists to visit the training facility periodically for reviewing the progress of work and for suggesting such measures as to ensure early realisation of the objectives of the project. On completion of the project five copies of a consolidated report of the work done on the subject would be submitted to RDWU.
- CUTM would furnish to RDWU a Utilization Certificate and an audited 6. statement of expenditure duly signed by the Head of the Institute and the Head of the Finance wing, pertaining to the grant before the release of subsequent installments as well as a consolidated statement of expenditure at the end of the completion of the project.
- 7. A stamped receipt be sent to RDWU on receipt of the Cheque/ Demand draft towards each release.
- The Comptroller of Finance, RDWU at his discretion shall have the right of 8. access to the books and accounts of the CUTM for the grant received from RDWU.

- CUTM would maintain separate audited accounts for the project. If it is found expedient to keep a part or whole of the grant in a bank account earning interest, the interest thus earned should be reported to RDWU.
- 10. CUTM may not entrust the implementation of the work for which the grant is being sanctioned to another institution and to divert the grant receipts as assistance to the latter institution. However, in such situations the express permission of RDWU may be obtained. In case the grantee is not in a position to execute or complete the project, it may be required to refund forthwith to the RDWU the entire amount of grant received by it.
- 11. The human resources that may be engaged for the project by CUTM are not to be treated as employees of RDWU and the deployment of such human resource at the time of completion or termination of project, will not be the concern/responsibility of RDWU.
- 12. RDWU reserves the right to terminate the grant at any stage and also to recover the amounts already paid if it is convinced that the grant has not been properly utilized or the work on the project has been suspended for any unduly long period or appropriate progress is not being made.
- 13. The project will become operative with effect from the date of release of the first instalment for the project.



1. Nature and Scope of Work:

1.1. Objectives for Project for which Grant has been provided:

The objectives of the project is to provide placement-linked Medical Skill Development Training to 200 Unemployed Youth Across East India & up-gradation of existing paramedical and allied health laboratory in the Bhubaneswar campus of Centurion University.


