PARTNERSHIP AGREEMENT

BETWEEN

CENTURION UNIVERSITY OF TECHNOLOGY AND MANAGEMENT, INDIA AND DAFFODIL INTERNATIONAL UNIVERSITY, BANGLADESH

This Partnership Agreement ("Agreement") is made and entered into on 18 March 2024, between Daffodil International University (hereinafter referred to as "DIU"), located in Bangladesh, represented by Professor Dr. M. Lutfar Rahman, Vice-Chancellor and Centurion University of Technology and Management (hereinafter referred to as "CUTM"), located in India, represented by Prof. Supriya Pattanayak, Vice Chancellor.

Purpose:

The purpose of this Agreement is to establish a collaborative partnership between DIU and CUTM for the development and implementation of various initiatives aimed at mutual growth and development.

Leadership:

Under this partnership agreement, the designated leaders/coordinators from both institutions shall play pivotal roles in facilitating effective communication, coordination, and implementation of collaborative initiatives and will work closely to foster synergy, innovation, and impactful outcomes.

DIU Leader/Coordinator: Dr. Mohamed Emran Hossain, Member of the Board of Trustees at DIU and Chief Operating Officer (COO) of the Daffodil Family, will serve as the leader/coordinator representing DIU's interests and initiatives within the partnership.

CUTM Leader/Coordinator: Mr. Babu Shankar, Managing Director of GramTarang Technologies, a social outreach start-up incubated within CUTM, will serve as the leader/coordinator representing CUTM's interests and initiatives within the partnership.

Industrialization and Commercialization of Products and Services:

Under this partnership agreement between DIU & CUTM, two respective sister concerns will collaborate closely for the industrialization and commercialization of products and services:

DIU will engage *Amar Pannya Ltd*, its affiliated startup (a concern of Daffodil Family) to contribute expertise and resources towards the industrialization and commercialization efforts.

CUTM will collaborate with *Gram Tarang Technologies*, its affiliated sister concern, leveraging its capabilities and innovations to drive industrialization and commercialization initiatives.

Together, Amar Pannya Ltd and GramTarang Technologies will work in tandem to facilitate the successful implementation and commercialization of innovative products and services emerging from the collaborative efforts between DIU and CUTM.

Areas of Partnerships and Terms:

The following table outlines key areas of partnership and terms between DIU & CUTM under this agreement. These encompass collaborative efforts spanning commercial production of furniture, apparel, electric vehicles; waste management; staff training; student skill development programs; student exchanges, and utilization of data center services, outlining a comprehensive framework for mutual growth and development.
