
1. The final recognition is valid for the academic session 2023-24 to 2024-25 only & the institution will be inspected for renewal of recognition in the academic session 2025-26.
2. The institution shall not admit students more than the approved intake seat capacity. No admissions shall be made beyond the validity period of the recognition.
3. No financial assistance/grant in any case in any form will be given by the State Govt. The institution will have to bear all the recurring and nonrecurring expenditure for all time to come.
4. The institution shall seek approval and affiliation from the concerned State Board and send the copy of the approval/ affiliation to the Chairman/Registrar for record.
5. All the conditions of affiliation prescribed by the affiliating Board will have to be met by the Institution.
6. The Institution cannot change their address or location without permission & the building intended for educational occupancy should not be used for any hazardous occupancy.
7. Admission fee and other charges will be as per the norms prescribed by Government/ affiliating Board.

8. The Government can impose any other condition(s) at any time, which shall be binding on the Institute and the State Govt shall not be responsible for providing employment to the pass out students.
9. If any complain/allegation received against the Institution during the period of recognition, surprise inspection shall be conducted & action as deemed fit shall be taken if any irregularities are found.
10. Any contravention of the above stated conditions shall result in withdrawal of the "Final recognition" and action deemed fit against the defaulting trust/ society/ institution.


